OF MERCHANT SHIPS, AND RECOGNIZED ORGANIZATIONS

**SUBJECT:** Radio Message Accounting Procedures and Accounting Authorities

PURPOSE: This Circular explains the radio message accounting procedures

required by the Administration and lists the Accounting Authorities

approved by the Office Administrator, IMSA Guyana

APPLICABILITY: This Circular applies to all Guyana registered vessels equipped with

ship radio stations.

### **REQUIREMENTS:**

**1.0** The International Telecommunication Union (ITU) Convention currently in force provides for Accounting Authorities to settle maritime radio communication accounts for ships under Guyana Ship registry.

- **2.0** Due to the many problems occurring in international radio maritime accounting, no ship is entitled to be registered or to maintain registration under Guyana registry unless the owner has entered into a valid contract with an authorized radio service company under the terms of which the company assumes the accounting obligation and may assume responsibility for obtaining the vessel's Ship Radio Station License.
- **3.0** It is mandatory that the approved Accounting Authority that has contracted with the owner of the vessel to settle all international maritime radio traffic charges for radio communications from ship to shore, both terrestrial and satellite.
- **4.0** The Accounting Authority for the vessel has assumed full responsibility for the payment of the radio communication charges and has further given a guaranty to the Republic of Guyana that no charges will accrue to the account of Guyana Ship Registry and, therefore, ensures that the guaranty remains fully effective. It is imperative that all radio traffic charges are sent to the Accounting Authority only and not to any third party.

5.0 ITU-T Recommendation limits the number of accounting authorities based in other countries that the Administration may recognize to twenty-five (25). The radio service companies approved by this Administration are listed in Annex to this Circular.
